PROCEDURE FOR E-VOTING AND VOTING THROUGH BALLOT PAPER

In continuation to the Notice Of Annual General Meeting (AGM) of Al Shaheer Corporation Limited ("the Company") scheduled to be held on December 05, 2023 at 09:00 a.m at The Royal Rodale Hotel, TC-V, 34th Street, Khayaban-e-Sehar, Phase 5, DHA Karachi, and in accordance with the Companies (Postal Ballot) Regulations, 2018 ("the Regulations"), the right to vote through electronic voting facility ("E-voting") and voting by post ("Ballot Paper") is being provided to the members of the Company in respect of special business to be transacted at the AGM which can be used alternately. M/s. Digital Custodian Company Limited has been appointed as E-voting service provider.

Procedure of E-Voting

- The web address, login details and password will be communicated to members via email and the security codes will be communicated to members through Email/SMS from the web portal of E-voting Service Provider. These details will be shared with those members whose names will appear in the Register of Member of the Company by the close of business on December 04, 2023.
- 2. Identity of the Members intending to cast vote through E-voting shall be authenticated through electronic signature or authentication for login.
- 3. Members shall cast their vote for Agenda Item No. 4, online at any time from December 02, 2023, 09:00 a.m. to December 04, 2023 till 05:00 p.m.
- 4. Once the vote has been casted by a Member, he/she shall not be allowed to change it subsequently.

Procedure For Voting Through Ballot Paper:

- 1. Duly filled and signed original Ballot Paper should be sent to the Company Secretary Al Shaheer Corporation Limited at Suit # G/5/5, 3rd Floor, Mansoor Tower, Block 8, Shahrah-e-Roomi, Clifton, Karachi or a scanned copy of the original Ballot Paper to be emailed at: cs@ascfoods.com.
- 2. Copy of CNIC/Passport (in case of foreigner) should be enclosed with the Ballot Paper.
- 3. Ballot Paper should reach Chairman of the meeting on or before December 04, 2023 during working hours. Any Ballot Paper received after this date, will not be considered for voting.
- 4. Signature on Ballot Paper should match with the signature on CNIC/Passport (in case of foreigner).
- 5. Incomplete, unsigned, incorrect, defaced, torn, mutilated, overwritten Ballot Papers will be rejected.
- 6. In case of corporate entity, Ballot Paper must be accompanied by the Board of Directors' resolution / power of attorney with specimen signature and copy of CNIC of the nominee etc. in accordance with Section(s) 138 or 139 of the Companies Act, 2017, as applicable. In case of foreign body corporate, all documents must be attested by the Embassy of Pakistan.
